## RESIDENTIAL SWIMMING POOL SAFETY AFFIRMATION

hereby affirm that the pool will be isolated from access from within the dwelling AND from adjacent properties by a barrier that meets the pool barrier requirements of Florida Statute 515.29 and the 2023 Florida Building Code Residential (8<sup>th</sup> Edition) R4501.17.

\_\_\_\_\_ The pool will be equipped with an approved safety pool cover that complies with ASTM F1346 (Standard Performance Specifications for Safety Covers for Swimming Pools, Spas, and Hot Tubs) per FBC R4501.17 Exception

\_\_\_\_\_ The pool will be isolated from access by a mesh safety barrier that meets the requirements of FBC. R4501.17.1.15

\_\_\_\_\_ The pool will be isolated from access by a screen enclosure that meets the requirements of FBC. R4501.17.1.11

\_\_\_\_\_ The pool will be isolated from access by a barrier and pedestrian gates that meet the requirements of FBC R4501.17.1.1 through R4501.17.1.8

\_\_\_\_\_ On a property next to a lake or waterway, the pool barrier fencing must extend into the water 3 feet past the lowest water level of the lake or waterway. The backyard can be fenced close to the lake if it meets zoning setbacks.

\_\_\_\_\_ All doors and windows providing direct access from the dwelling to the pool will be equipped with an exit alarm that meet the requirements of FBC R4501.17.1.9(1) unless Exceptions a, b, or c apply

\_\_\_\_\_ All doors providing direct access from the dwelling to the pool will be equipped with self-closing, self-latching devices installed 54" above the threshold that meet the requirements of FBC R4501.17.1.9(2)

\_\_\_\_\_ The pool will be isolated from access by a mesh safety barrier that meets the requirements of FBC R4501.17.1.15

\_\_\_\_\_ A swimming pool alarm that, when placed in a pool, sounds an alarm upon detection of an accidental or unauthorized entrance into the water. Such pool alarms must meet and be independently certified by ASTM.

I understand that the above-indicated equipment shall be installed before the pool safety inspection per FBC R4501.17.1.9.
